He acknowledged that the material being sent to Sexton's CCDD permitted facility (IEPA Permit #0311800001) by contractor(s) Illinois Department of Transportation., (as General Contractor) must still provide proper IEPA documentation to Sexton in addition to this IDOT form. The forms required by the IEPA that Sexton must fulfill required LPC-663 Form AND that all inbound loads will be subject to inspection procedures dictated by IEPA rules & regulations upon arrival to the Sexton Richton Park Facility including (as required) P.I.D. (Photo Ionization Detector) inspections & PH inspections. Any load not meeting such standard is subject to rejection (by Sexton personnel) and notification to the IEPA shall be made within 24 (as required by the IEPA) regarding such rejection of load(s).
